

Privacy Policy

Site visitors

Information collected in this way does not reveal your contact details or any type of Personal Data. This information is only used in aggregate form to analyse, manage and develop the Face à Face French Grinds website and is not linked to any individual.

Contact us webpage form

If you send us an email through our contact us webpage form, we will collect and hold Personal Data about you when you email us. The Personal Data collected by us through our website when you contact us include your full name, your phone number and e-mail address.
